CONTEST RULES AND SUBMISSION CRITERIA FOR SUN PRAIRIE CABLE ACCESS TV VIDEO CONTEST

RESIDENCY REQUIREMENT: *THE PRODUCER MUST LIVE IN THE SUN PRAIRIE AREA SCHOOL DISTRICT.*

VIDEO CONTENT: *THE VIDEO SHOULD BE ORIGINAL MATERIAL THAT IS MEANT TO ENTERTAIN, EDUCATE, AND/OR AMUSE. (i.e., sitcom, comedy, drama, travel log, etc.)*

VIDEO LENGTH: *THE CATEGORY OF OVER 18 ALLOWS FOR 30 MINUTES ALL OTHER AGE CATEGORIES ARE NOT TO EXCEED 15 MINUTES.*

VIDEO AUDIENCE RATING: *THE CONTENT OF ALL VIDEOS MUST BE APPROPRIATE FOR A "G" MOVIE RATING. ANY VIDEO SUBMITTED THAT DOES NOT MEET THIS REQUIREMENT WILL BE RETURNED UNJUDGED.*

REQUIRED RELEASE FORMS: *ATTACH SIGNED RELEASES FROM ALL PRODUCERS, WRITERS, DIRECTORS, ACTORS AND ACTRESSES TO THIS FORM. NO VIDEO WILL BE CONSIDERED IF A RELEASE IS OUTSTANDING.*

DEADLINE: *ALL SUBMISSIONS ARE DUE IN THE S.P. CABLE ACCESS OFFICES LOCATED AT 1350 LINNARD DRIVE (LIBRARY BUILDING) BY 4:00 P.M. FRIDAY, JULY 31ST.*

JUDGING: *EACH ENTRY WILL BE JUDGED BY A PANEL OF JUDGES FOR DEVELOPING AND MAINTAINING VIEWER INTEREST, DEVELOPING MESSAGE OR THEME, OVERALL PRODUCTION QUALITY, LEVEL OF ARTISTIC EXPRESSION, AND OVERALL RATING OF THE PROJECT. JUDGING CATEGORY DETERMINED BY AGE OF OLDEST PRODUCER.*

THE DECISION OF THE JUDGES WILL BE FINAL.
